A complete application consists of:

- Application Acknowledgement Letter
- Printed copy of Online Application Form (duly completed, signed and affixed with a recent passport-sized photograph).
- Copy of Passport page (clearly reflecting full name and date of birth).
- Official Bachelor's/Master's Degree Transcripts (with English translation if applicable, as well as in its original language)
- Certified copy of Bachelor's/Master's Degree Certificate (with English translation if applicable, as well as in its original language)
- Official ranking / Cumulative Grade Point Average / Grading system, where applicable.
- Official TOEFL or IELTS score report (where applicable. Refer to Language Requirements as stated below)
- Resume or Curriculum Vitae
- Two academic referees' report (to be submitted online by referees)
- A copy of the online application fee receipt
- Personal Statement

LANGUAGE REQUIREMENTS	Minimum TOEFL iBT 100. A minimum TOEFL (paper-based) score of 600 and IELTS (Academic) of minimum 7.0 will be considered, but we strongly prefer the iBT. (Applicable to applicants from non-English medium institutions)

COURSE REGISTRATION	All students are required to first complete an online pre-registration prior to reporting in person to the relevant registration centre to complete the registration procedures, which normally commences in the week before the beginning of semester 1. More details on registration procedures will be provided after acceptance of offer.

HOUSING	Accommodation options range from university housing (which is limited) to hostels and rooms/apartments in the private housing market. NUS hostel rates range from S\$78 to S\$207 per week for the double/single rooms and S\$306 to S\$435 per week for the married students' apartments. Rentals for a room in a private apartment can vary widely, depending on its location. Rates per person are lower if the apartment is shared, or if a room is found in a hostel. Before signing any rental contract, note that the university's academic year lasts for 10 months and would conclude by mid-May of the following calendar year. HEALTH INSURANCE REQUIREMENTS	All full-time international students are required to subscribe to NUS Full-time Student Insurance Scheme when admitted to NUS. The health insurance fee will be included in the Miscellaneous Student Fees of the student bill on a semester basis. <b>This is a compulsory scheme. No opt-out is allowed.</b>
VISA INFORMATION	All international students must hold a valid Student's Pass issued by the Singapore Immigration and Checkpoints Authority for their studies at NUS. Once an international applicant indicates acceptance of the offer, NUS will submit an application for the Student's Pass on behalf of the applicant. Each new application must be submitted at least one month and not more than two months before the commencement of the course.
